### PLEASE NOTE:

- Duplication of images is determined on a case by case basis. If a document or photograph is too fragile to be handled or scanned the Museum will not be able to generate a digital copy of it.
- The National Building Museum must confer with the original donor before we can release some images from the Northwestern Terra Cotta collection. Submission of this form is not a guarantee that images will be released.
- For research visits to the Museum's permanent collection the Processing Fee structure detailed on page 3 of this document will be applied. Fee will be waived for student researchers presenting a valid student ID.

#### TURN-AROUND:

- Turn-around time for a research request of up to 20 images is two to three weeks from the receipt of the completed and signed form. Information on orders over 20 images is available upon request.
- Research visits must be scheduled in advance and are subject to the Museum's operating hours as well as the schedules and availability of Collections Department staff. Research visits cannot be accommodated on weekends or federal holidays.

#### INVOICES AND FEES:

- The National Building Museum charges individual, non-profit, and commercial users fees in order to support the maintenance of the collections. Use fees will be determined from the information on the permission form.
- Invoices are sent out either with the material requested or mailed within one week of delivery images sent digitally. Invoices for a research visit will be sent out after the visit has occurred. Payment is due within 30 days of receipt of invoice.
- At this time the Museum **can only accept payment via cash, check, or electronic transfer.** All checks should be made out to National Building Museum. If you would like to utilize the electronic transfer option, request instructions from the Collections Manager.

## RESEARCH / DIGITAL REPRODUCTION ORDER FORM AND USE AGREEMENT

### TERMS AND CONDITIONS

#### Definitions:

The following terms have the following meanings when used herein: **“First Edition”** means the first version of the distributed Work that incorporates the Image(s) on the Order Form (page 5). **“Image”** means each photograph, negative, slide or electronic digitized picture of the object(s) listed on the Order Form (page 5). **“Work”** means the print, website or film product described on Page 1. **“Territory”** means the language (English, other language, or worldwide rights) of the Work.

#### Permission for Use

The National Building Museum grants non-exclusive, non-transferable, limited permission to use the Image(s) in the First Edition of the Work and in accordance with the terms of this Permission for Use. The Work may only be sold or distributed in the Territory. The Image(s) may be used only within the body of the Work and may not be distributed or published in any other form or medium. Satellite, electronic, broadcast, on-line or network access, distribution or transmission of the Image(s), or the Work, or any part thereof, is expressly prohibited for any purposes. Nothing set forth in this Permission for Use shall restrict the Museum’s right to the Image(s), including the right to allow others to use the Image(s). The Museum’s name may not be used in any manner in connection with the Work, unless expressly agreed to and/or required by the Museum in writing.

#### Fee and Language/Territory

This Permission for Use requires payment to the Museum a non-refundable fee per image reproduced. Fees are dependent on the type of USE and are described in the **NATIONAL BUILDING MUSEUM USE FEE SCHEDULE**. This Permission for Use is limited to a print run in one edition only, over a period not to exceed 10 years from the date of this document.

#### Image Requirements

No Image may be in any way distorted, whether by rotation, inversion, and change of proportion, color alteration, superimposition, animation, or other method without the prior approval of the Museum. Details of an Image may be used, subject to the prior approval of the Museum, and must be labeled as such in the publication. No Image may be cropped more than 10 percent in any dimension, over-printed, or otherwise altered without the Museum’s permission.

#### Documentation of Images

Full documentation must appear exactly as specified by the Museum without editing, omissions or use of abbreviations or acronyms, either adjacent to the reproduction on the page, or with list of sources and credits within the publication. Full documentation will be supplied by the Museum with the Image(s).

#### Rights

All rights in the Image(s), and any documentation and related text supplied by the Museum, including without limitation any copyrights, other than the nonexclusive permission granted herein, will remain vested in the Museum.

#### Warranties and Indemnities

The Museum warrants and represents that so far as it is aware, but without investigation, the permission granted by it hereunder will not infringe the rights of any third party. Notwithstanding the foregoing, the Museum is acting only as an owner of the physical original.

*The Museum is not responsible for determining the copyright status of the Image(s), or for securing copyright permission and the payment for any such permissions required. The rights granted under this Agreement do not include any rights that persons other than the Museum may have in the Images or Work, including any artists' rights of attribution or control under the laws of any country or state, moral rights, or the rights of publicity or privacy.*

Except as expressly set forth herein, the Museum disclaims any warranties, expressed or implied, including warranties of non-infringement of fitness for a particular propose.

The party to whom use is herein granted warrants and represents that the Work, as distinct from the Images subject to Museum's warranties above, will not violate or infringe upon the rights, including, without limitation, copyrights, or any other intellectual property rights, moral rights or publicity or privacy rights of any other person or entity. User of Image(s) hereby indemnifies and holds Museum harmless against any costs, expenses, losses, damages, judgments and claims (including court and attorney fees) that Museum may suffer or incur: (i) as a result of a claim of any third party based on or arising out of the Work; or (ii) arising from the Image user's breach of any provision of this Agreement.

**Complimentary Copy of Work**

Where applicable, the Museum will be furnished, free of charge, with one copy of the Work within thirty (30) days of publication/production.

**Credit**

Unless otherwise stated, the credit line must read "Courtesy of the National Building Museum."
